Additionally, our roadmap includes plans to launch our own delegation service on Steemit, NFT marketplace and gaming projects within the PussFi Ecosystem, where \$PUSS will serve as the native utility token. Furthermore, the deflationary coin model and LP buyback strategy are designed to ensure the sustainability of \$PUSS in the long term.
